#### **OMA Notification Requirements**

Remember that if you have to hold a district board meeting at a date, time or location that deviates from the information you advertised in your Open Meetings Act resolution, you must advertise it accordingly. Here are the guidelines:

Regular Meeting – 10 Days Prior Special Meeting – 3 Days Prior Emergency Meeting – 24 Hours Prior

## 2. Mill Levy Rate Resolutions and Appointed Supervisor Nominations

Please submit your Mill Levy Rate Resolutions and Appointed Supervisor Nominations to the SWCC by June 1<sup>st</sup>. Appointed Supervisor nominations should be submitted for **each** supervisor in positions 6 and 7. Attached is the Appointed Supervisor Form, to be filled out for both Appointed Supervisor positions and submitted to the SWCC.

## 3. NMDA's Healthy Soil Program grants: Register for March 5 webinars; apply for a grant by April 26

Between February 23 and April 26, NMDA will accept Healthy Soil Program grant applications from SWCDs and other Eligible Entities, as well as from Individual Applicants whose projects are sponsored by their SWCD or tribal government. Projects submitted for funding consideration must address 1+ identified soil health-related resource concerns by implementing 1+ of the 5 soil health principles. Project activities cannot start earlier than August 1, 2024 or end later than May 24, 2025.

## 4. 2024 Water Quality & Conservation Grant

The New Mexico Soil and Water Conservation Commission (SWCC) annually receive a legislative appropriation from the State of New Mexico to be used for special projects relating to water quality and conservation. These funds are awarded by the SWCC through the Water Quality and Conservation (WQ&C) Grant Program. The goal of the grant program is to promote the health of New Mexico's watersheds and conserve the water resources they produce. A limited number of projects addressing one or more of the following areas will be funded over the next fiscal year:

- 1. Watershed Improvement/Management
- 2. Irrigation Efficiency
- 3. Riparian Restoration

- 4. Natural Resource Information and Education
- 5. Ground Water Protection/Conservation
- 6. Noxious Weeds

The RFP for the WQ&C grant was sent out to all SWCDs the beginning of February. All proposals are due <u>Friday</u>, <u>April 5th by 5:00 pm</u>. The proposal needs to be in <u>Microsoft</u> <u>Word formatted</u> version and emailed to: <u>swcc@nmda.nmsu.edu</u>. Faxed copies will not be accepted.

## 8. Review 2024 state legislation enacted by Gov. Lujan-Grisham

If you're interested to learn which bills passed by the 2024 New Mexico Legislature were enacted by Gov. Once there, you'll see bills listed in order of when the Governor signed them into law, from least to most recently.

Clicking on one of the bills listed under "2024 Signed Legislation" will take you to the corresponding page on the New Mexico Legislature's website (www.nmlegis.gov). Once on the legislative website, look for a gray button with the text "Final Version"; this represents what the Governor actually signed into law. Avoid clicking on other gray buttons (such as those that say "Introduced (PDF)" and "Introduced (HTML)"), as those versions are outdated and, thus, could be vastly different from what is now state law.



## 9. SWCD Zoning

Districts who might be considering zoning their SWCD, please see the relevant section of the District Act, linked below. If you have any questions, please contact your SWCD specialist.

#### 73-20-39. Election of supervisors; district zones.

In adopting and publishing rules for the election of supervisors and the registration of district voters, the commission may, to ensure proper representation of district voters and to facilitate district functions, provide for the geographic zoning of a district. The commission shall

provide for the proper and equitable representation for each faction geographically zoned in the district. If a district is divided, or if two or more districts are consolidated, the commission shall provide for the geographic zoning of the resulting district or districts within thirty days after the secretary of state issues the certificate of organization for each new district.

**History:** 1953 Comp., § 45-5-54, enacted by Laws 1965, ch. 137, § 13; 1973, ch. 324, § 8; 1977, ch. 254, § 69; 2003, ch. 88, § 12.

#### **ANNOTATIONS**

**The 2003 amendment,** effective June 20, 2003, deleted "district" from the section heading; substituted "publishing" for "promulgating" near the beginning of the section, deleted "district" following "election of" near the beginning of the section and substituted "voters" for "landowners" near the middle of the section.

Election of soil and water conservation district's board of supervisors must comply with principle of "one person, one vote". — Where petitioner filed a petition for writ of mandamus in the district court objecting to the adoption of geographic voting zones with significantly unequal population for the election of the Dona Ana County Soil and Water Conservation District's board of supervisors, arguing that the voting zones, as drawn, violated the United States Constitution's "one person, one vote" requirement, diluting the voting power of petitioner and the other residents of the zone that includes the City of Las Cruces, and where the district court found that the soil and water conservation commission's approval of the voting zones was not authorized by the legislature, was inconsistent with the commission's statutory duty under 73-20-39 NMSA 1978 of the New Mexico Soil and Water Conservation District Act to ensure proper and equitable representation of district voters, and was in violation of the "one person, one vote" mandate of the United States Constitution, the district court did not err in granting the petition for writ of mandamus, because the inequality in population of the zones conflicted with both 73-20-39 NMSA 1978 and with the equal protection clause of the United States Constitution. Price v. N.M. Soil & Water Conservation Comm'n, 2023-NMCA-011.

#### 10. Reminder to Renew Chief Procurement Officer Certificate every Two Years

**Your CPO** Certification *expires* EVERY two years and it is **your responsibility** to renew your certificate. Please take time to add this to your calendar and other devices to help remind you.

#### Per NM EDGE

- Chief Procurement Officers are required to re-certify ("per § 13-1-95.2 (D) NMSA 1978") every and within 2 years (based on the month of initial certification).
- It is the responsibility of the CPO to re-certify before their current certification lapses.
- NM EDGE offers Foundation and Recertification classes every quarter.

### 11.NMSU Extension Hosts NM Youth Ranch Management Camp

The 2024 New Mexico Youth Ranch Camp will be held June 9-14. This year the camp will be held at the CS Ranch near Cimarron, NM.

The camp, designed for New Mexico youth ages 15-19, is an effort to reverse the aging trend in ranching. Nationally, the average age in the ranching community continues to increase as more young people are opting to leave the ranch for careers outside of production agriculture. As a result, the fabric of rural economies, as well as ranching tradition and cultures, are in jeopardy. In a rural state like New Mexico, the situation has significant implications.

### 12. Office of Agriculture and Rural Affairs

The new Office of Agriculture and Rural Affairs will be led by Rod Snyder, who has served as Administrator Regan's Senior Advisor for Agriculture since October 2021. The new office will expand on the work of the Ag Advisor and increase coordination with a network of existing agriculture policy advisors located in all ten EPA regional offices across the country.

In close coordination with EPA's program offices and regions, the office will forge practical, science-based solutions that protect the environment while ensuring a vibrant and productive agricultural system. In support of the Biden-Harris Administration's Rural Partners Network, the new office will also collaborate with small, underserved towns and rural communities that are seeking federal investments in infrastructure upgrades and other community improvement opportunities.

Additionally, the new office will facilitate closer coordination with relevant federal and state partners such as the U.S. Department of Agriculture, U.S. Food and Drug Administration, and state departments of agriculture. The office will also house EPA's existing Farm, Ranch and Rural Communities Federal Advisory Committee (FRRCC). The Committee provides independent policy recommendations to Administrator Regan on a range of policies that impact agriculture and rural communities.

#### 13. Information on NM's 50 Year Water Action Plan

On January 30, 2024, Governor Michelle Lujan Grisham unveiled a water action plan at the State Capitol with the goal of ensuring New Mexicans will have access to clean water for the next five decades.

As one of the driest states in the west, New Mexico is no stranger to drought. Almost three-fourths of the state is currently experiencing severe to exceptional drought conditions. In 50 years, water experts predict the state will have 25 percent less water to use. Without decisive action, New Mexicans would have to dramatically adjust their way of life to adjust to a bleak water reality.

Understanding this fact, the Lujan Grisham administration — with the help of leading scientists, hydrologists, geologists, and researchers — created a 50-Year Water Action Plan to safeguard the state's most precious resource for future generations.

Key provisions of the 50-Year Water Plan include:

- A water education campaign to reduce community water consumption by 10%.
- Expanding water conservation by incentivizing modern irrigation technology to reduce agricultural water use by 20%.
- Deploying cutting-edge technology to complete a statewide water loss inventory.
- Creating billions of gallons of new water for use for clean energy manufacturing via the Strategic Water Supply.
- A new surface water discharge permitting program to keep rivers, streams, and lakes clean.
- Investing in reforesting and managing forests to protect water supplies and reduce the threat of wildfires.

## 14. NM Mexico Forestry Division Spring 2024 Conservation Seedling Sale

Ordering for seedlings from the NM Forestry Division Conservation seedling program for Spring 2024 begins December 4, 2023, and orders will be accepted through April 19, 2024. Distribution of seedlings begins March 11, 2024, and ends on April 26, 2024.

The cost of seedlings is \$90.00 per 49 small container seedlings, \$64.00 per 50 bareroot seedlings. Also available: Rocky Mountain juniper available in 16 cubic inch containers for \$57.00 per 20 seedlings and Prairie Sky poplar available in 40 cubic inch containers for \$90.00 per 20 seedlings. Please note there is a \$5.00 handling fee per order and for each lot of seedlings ordered that are shipped UPS there is a \$20.00 shipping fee.

## 15. Certified Burn Manager Training from New Mexico Forest Division now available online

New Mexico Forestry Division's free Certified Burn Manager Training online nine-element training is now live and available on our Canvas platform at

https://nmforestryrx.instructure.com/login/canvas. You also can find the link to this training on the New Mexico Forestry Division website at <a href="https://www.emnrd.nm.gov/sfd/prescribed-burning/">https://www.emnrd.nm.gov/sfd/prescribed-burning/</a>. This training is one of the key elements to becoming a certified burn manager and one or all elements of the nine-element training are mandatory to be a certified burn manager whether seeking pile burn certification or broadcast burn certification. All users will need to create an account on the Canvas platform in order successfully enroll into the nine-element training whether you are seeking pile burn certification or broadcast burn certification. This training is self-paced, and all interested are highly encouraged to enroll. 

# Land of Enchantment Legacy Fund (LOE fund): Background Information

- LOE was created as a part of a permanent fund
  - For several state agencies
    - Senate Bill 9 (SB9) passed 2023 legislative session

July 1, 2024 and each year thereafter

 an annual distribution shall be made from the
 LOE Fund; NMDA's share is 22.5%



## LOE Fund Background Information Continued...

The LOE Fund will support

- Soil and Water Conservation Districts (SWCDs) and Watershed District programs (WDs)
- NMDA's Noxious Weed Program
- NMDA's Healthy Soil Program
- ALERT: This pilot project funding for NMDA's share of LOE Fund grants only pertains to SWCDs and WDs. Not individual applicants.



# Four Types of Project Applications Available

- Capacity-Building Projects
- Conservation Planning and Land Use Planning
- Landscape-Scale Restoration Projects
- Community Outreach and Education Projects



# SWCDs can apply for LOE fund grants for all of the following types of projects:

Amount of Grant	Type of Grant	Who can apply?	How often?
Up to \$20,000	Capacity-Building Project	SWCDs and WDs	Every other year
Up to \$25,000	Conservation Planning & Land Use Plans	SWCDs only	Once
Up to \$250,000	Landscape-Scale Restoration Project	SWCDs and WDs	Annually
Up to \$1 <i>5</i> ,000	Community Outreach and Education Project	SWCDs only	Annually

 SWCDs and WDs may submit one or more applications, for one or more types of projects.



## LOE Funding – Compliance with Reporting Requirements

- SWCDs and WDs must be in compliance with reporting requirements from
  - Department of Finance & Administration
  - Office of the State Auditor
  - SWCC reporting requirements with quarterly budget reports, annual budget, and mil levy resolutions
- If not, do not proceed with applying





# Before applying, please do the following:

- SWCDs and WDs applying for Landscape-Scale Restoration projects must have:
  - An up-to-date Unique Entity Identifier (UEI)

New Mexico Department of Agriculture

- UEIs replaced DUNS numbers in April 2022
  - SWCDs lacking a UEI can apply at <u>sam.gov</u>
    - This process is free, but can take 6 weeks or more, to receive a UEI.

# **Budget Considerations**

- The value of each durable good in the budget must not exceed \$4,999.99.
  - Such as computers, office equipment, field equipment, and other long-lived tangible items





- In addition to the budget required to implement the project,
  - The SWCD or WD implementing the project will be granted an administrative fee of
    - 10, 15, or 20% of the project budget; if the requested administrative fee is more than 10%, a justification must be provided.
- Capacity-Building projects will not be allocated an administrative fee.



# **SWCD** Guidelines and Considerations

- Projects should fit within the purpose of Soil and Water Conservation Districts as defined in the Soil
  and Water Conservation District Act:
  - control and prevent soil erosion;
  - prevent floodwater and sediment damage;
  - Further the conservation, development, beneficial application and proper disposal of water;
  - Promote the use of impounded water for recreation, propagation of fish and wildlife, irrigation and for urban and industrial needs; and
  - By the application of these measures, conserve and develop the natural resources of the state, provide for flood control, preserve wildlife, protect the tax base and promote the health, safety and general welfare of the people of New Mexico



## WD Guidelines and Considerations

- Watershed Districts must obtain a letter of support from the local SWCD that oversees the watershed district
- Projects should fit within the purpose as defined in the Watershed District Act:
  - Develop and execute plans and programs relating to any phase of conservation of water, or of water usage, including:
    - Water-based recreation
    - Flood prevention
    - Flood control
    - Erosion prevention and control of erosion
    - Floodwater and sediment damages



## Guidelines and Considerations for SWCDs and WDs

Proposals that are for project planning under **capacity-building** and do not have an immediate on-the-ground component:

- Must explain how the project planning will assist the district in implementing on-the-ground projects
- There must be a clear explanation of how the district plans to implement their project plan, once completed.
- Project planning budgets for capacity building cannot exceed \$20,000.



# Guidelines and Considerations for SWCDs and WDs continued...

- Consideration of landscape-scale restoration projects wherein multiple SWCDs participate regionally to accomplish projects will be considered high priority






# Landscape-Scale Restoration Projects Continued...

- Landscape-scale restoration/conservation means projects
  that effectively leverage federal and non-federal dollars to
  restore healthy and resilient landscapes and communities across
  multi-jurisdictions
- Projects are encouraged to match and leverage federal funding with a 1:1 match
  - if your district is unable to provide match, there will be an opportunity to explain in the application
  - The collaboration and multi-jurisdictional projects are emphasized over the 1:1 match
- Must include an education and outreach component





# Landscape-Scale Restoration Projects Continued...

- Noxious weed projects must be a follow-up to restoration
- Vegetation and noxious weed management activities will be considered for funding only if:

they have a direct relationship with other proposed or completed restoration activities and objectives related to the restoration project that is being applied for

- Only SWCDs and WDs are eligible for these funds; Cooperative Weed Management Areas are <u>not eligible</u> for these funds!
- <u>Important: produced water, brackish water, and saline water projects</u> are not eligible for funding!

Evaluation Method 2. We will have an email list signup sheet that will directly reflect how many participants engaged with our event.

- Project planning budgets for capacity building cannot exceed \$20,000.

#### 1. What is the Land of Enchantment Fund?

The Land of Enchantment Fund (LOE Fund) was created as part of a permanent fund for several state agencies through Senate Bill 9 passed in the 2023 legislative session; on July 1, 2024 and each year thereafter, an annual distribution shall be made from the LOE Fund to recipient agencies.

New Mexico Department of Agriculture's share of the LOE Fund distributions will support Soil and Water Conservation Districts and Watershed District programs, NMDA's Noxious Weed Program, and Healthy Soil Program.

#### 2. Which agencies is the Land of Enchantment funding available through?

The permanent fund was created for several state agencies, but this particular Land of Enchantment Fund is specifically for Soil and Water Conservation Districts through the New Mexico Department of Agriculture.

#### 3. When is the grant application available?

Friday, March 1, 2024 at noon until Friday, May 3, 2024 at noon.

#### 4. What is the term/length of the grant?

Projects funded through NMDA's Land of Enchantment grants will last approximately 10 months. Project activities cannot start until the Memorandum of Agreement (MOA) and Purchase Order agreement (PO) have been signed and sent back to NMDA, and NMDA has given you written authorization to begin. Project activities must be completed and completely invoiced by 5 p.m. Mountain Time on May 15, 2025.

### 5. Will we know if our project is selecting for funding before we have to turn in our budgets for FY25?

All applicants should be informed by June 30 if their project was funded or not.

#### 6. How/where does a soil and water conservation district apply?

- a. Via Submittable, which is NMDA's grant-application portal https://grants.nmda.nmsu.edu/
- b. Faxed or emailed copies will not be accepted
- c. Late or incomplete applications will not be accepted

#### 7. What are some examples of projects for the different pools of funding?

Think outside of the box, be creative, and apply! Only your district knows what the needs of the district are.

#### **Capacity Building**

Some project ideas could include, but are not limited to: developing an Infrastructure Capital Improvement Plan (ICIP) in order to pursue capital outlay funding; hire a contractor or staff to build capacity; project design or preliminary professional review/assessment of dam or infrastructure conditions; or projects that will enable SWCDs and WDs to meet their long-range plan and mission.



#### **Conservation Planning or a Land Use Plan**

This funding pool is exactly as it reads. #### **Landscape-Scale Restoration**

Landscape scale restoration/conservation means projects that effectively leverage federal and non-federal dollars to **restore healthy and resilient landscapes** and communities across **multi-jurisdictions**.

Examples include: fire mitigation, post-fire restoration, and watershed restoration, etc. Other ideas are welcome. Be able to explain how/why a project is restorative. How will it restore healthy and resilient landscapes? If it's a conservation project, rather than a restoration project, then explain how it'll help maintain healthy and resilient landscapes and how it'll benefit multi-jurisdictions.

Noxious weed projects must be a follow-up to restoration; otherwise SWCDs and WDs must apply for such funding through other grants. Vegetation and noxious weed management activities will be considered for funding only if they have a direct relationship with other proposed or completed restoration activities and objectives related to the restoration project that is being applied for.

#### **Community Outreach and Education**

What projects for outreach and education activities does the district have in mind, that are not tied to a landscape-scale restoration project? Educational videos on district projects and other forms of outreach are welcome. Think of project ideas the district has successfully completed through other grants that were education and outreach. That can help spur ideas on possible future projects. What does the district want their community to know? What does the district want to educate their community about?

### 8. We're not sure what types of projects are considered restoration. What if it's more of a conservation project, does that qualify?

Districts are strongly encouraged to flesh out their project ideas to have a better idea if it would fit under one of the four pools of funding.

We encourage the SWCDs and WDs to apply for funding, and if a project isn't funded through the LOE Fund, then the district has potential projects ready to submit for other funding opportunities.

Refer to the previous question for guidance, to see if the district's restoration/conservation project ideas might qualify.



#### 9. Please provide more information on the different funding pools.

# 10. Must landscape-scale restoration projects specifically match and leverage federal funding? NMDA requires that projects match and leverage federal funding with a 1:1 match, but if there is other match, please include that in the budget template.

### 11. What if we don't have federal 1:1 match for landscape-scale restoration projects? You will be able to provide a justification for why not. Your application won't be automatically excluded.

#### 12. Can the LOE Funding be matched with other state funds?

Yes, local, state, or federal match. But, priority is given to federal 1:1 match.

#### 13. Is the funding match a "match" or "leverage?"

Both, it's one and the same. Be specific about your match/leverage in the budget template.

#### 14. Can landscape-scale restoration be done on public land?

Yes, it can be done on any type of land, as long as there is authorization to perform the work on that land.

#### 15. Do education projects require a match?

No, only the Landscape-Scale Restoration category requires match, but it's encouraged for the other three categories, if possible. If match can't be met in the Landscape-Scale Restoration category, then explain in the justification. Your project won't be automatically excluded.

### 16. Could the capacity-building be supplemented by a different grant from a municipality, the county, or the state?

Yes, but Landscape-Scale Restoration Projects is the only funding pool requiring federal 1:1 match at this time. If match can't be met in the Land-Scale Restoration category, then explain in the justification. Your project won't be automatically excluded.

#### 17. Can our match be from the previous fiscal year?

It can, but only if it's a multi-year project into the fiscal year for which you're awarded LOE monies.



18. If a current project is being completed on the eastern side of the district, and we want to apply for LOE funding to expand the project to the western side of the district, can we consider that match?

If it's the same exact project, then there's no issue with counting it as match, so long as it's a current project.

19. How is the grant funding going to be administered?

Funding is distributed on a cost-reimbursement basis, meaning that the SWCD or WD must first incur the cost of an approved budget item. The SWCD or WD then must invoice NMDA with corresponding receipts in order to be reimbursed. NMDA strongly encourages SWCDs and WDs to invoice NMDA early and often. Do not wait until the end of the grant term to submit all of your project invoices and corresponding receipts.

- 20. What if our entire district is in a Cooperative Weed Management Area (CWMA)? Does that disqualify us from applying for the LOE Fund restoration funding?

  No, but CWMAs can't apply for funding.
- 21. What if our CWMA is a partner on the restoration project, does that disqualify us from funding?

No. The criteria listed, states that CWMAs can't apply for funding.
