### 1. Dylan Burruss hired as new NMDA Noxious Weed Coordinator

On July 1<sup>st</sup>, NMDA hired Dylan Burruss as its new Noxious Weed Coordinator. Dylan is based out of NMDA's Las Cruces office, but will be working with SWCDs and other stakeholders statewide. Here is Dylan's background in his own words:

I am originally from a small agricultural and fishing community in Eastern Virginia, and I relocated to New Mexico to earn an MSc in ecology and a minor in statistics from NMSU. For the last ten years, I have worked as a data scientist, where I have developed models to predict the distributions of rare and cryptic wildlife, wildlife/livestock disease, arthropodborne viruses, extreme drought impacts on grassland ecosystems, and factors that control invasive plant germination and establishment in the Chihuahuan Desert.

### 2. Healthy Soil Program grant-funded projects start August 1

This month marks the start of projects selected for Healthy Soil Program grant funding in Fiscal Year 2025 (FY25). **Before doing any other project activity**, all grantees – Eligible Entities and Individual Applicants alike – must have their soil **tested** (by taking samples and sending them to the lab named in their grant application) **and assessed** (by performing various in-field evaluation techniques themselves).

SWCDs that are sponsoring Individual Applicant projects selected for grants are expected to assist those Individual Applicants as they collect their soil samples for lab-based testing and as they assess their soil in the field. Such assistance is one of the activities for which the Project Sponsor is paid a 15% administrative fee.

# 5. NM Environment Department accepting public comment on Outstanding National Resource Waters designation until August 19

#### From NMED press release dated July 20

The New Mexico Environment Department (NMED) Surface Water Quality Bureau (SWQB) is nominating certain surface waters of the state as Outstanding National Resource Waters (ONRWs). ONRWs are surface waters that receive enhanced protection against degradation under state and federal statutes and regulations. Degradation of baseline or existing water quality is not allowed in ONRWs except under limited circumstances.

The SWQB is holding a public comment period on the nomination and amended regulatory language starting on July 20 and ending on August 19, 2024, at 5:00 PM MDT. Comments will be accepted via mail, email, and NMED's smart comment portal at <a href="https://nmed.commentinput.com/comment/search">https://nmed.commentinput.com/comment/search</a>. The draft nomination, amended regulatory language, and additional information are available on our Smart Comment Portal and NMED's website at <a href="https://www.env.nm.gov/surface-water-quality/wqs/">https://www.env.nm.gov/surface-water-quality/wqs/</a>. We also plan on holding at least one public meeting regarding this action in August. Details for registering and participating in this meeting will be announced through this listsery. After consideration of the comments and feedback we receive, the SWQB anticipates petitioning the WQCC in September for a December 2024 hearing to designate waters as ONRWs.

# 8. NEW Inspection of Public Records Act Guide by the NM Department of Justice

Attorney General Raúl Torrez announced the release of the New Mexico Department of Justice's new Inspection of Public Records Act (IPRA) guide, a comprehensive resource for government transparency in New Mexico. By helping shine light on the affairs of state and local government, IPRA is a fundamental tool for promoting good government in New Mexico. Historically, the IPRA guide has helped governmental agencies, municipalities, counties, and other local governments with IPRA. Because the IPRA guide had not been revised for almost ten years, AG Torrez made revamping and updating the guide a priority as part of his commitment to supporting transparent and accountable government in New Mexico.

Navigating IPRA can be intricate and challenging, especially for those new to the process. With real-world scenarios and explanations of the law, the revamped guide is designed to be used by readers without a legal background, while also providing references to specific laws, court opinions, and other more technical legal analysis that are useful for attorneys, legal professionals, and other IPRA practitioners. The real-world examples help demystify the complexities of IPRA compliance and empower cities and local governments to fulfill their obligations under IPRA with confidence and clarity.
